3. **DISTRICT COUNCILLOR'S –**

Cllr. May and Cllr. Nock - report below:-

Bromsgrove Local Plan and the Draft Development Strategy (DDS)

You will recall we have previously talked about the Strategic Planning Steering Group and its purpose regarding the Bromsgrove Local Plan and DDS Consultation.

As Karen and I have explained between now and 2043, in accordance with the revised National Planning Policy Framework (NPPF), we need to allocate enough land for circa 12,000 new homes to meet our Local Housing Need (LHN) and around 28 hectares of employment land for manufacturing and warehousing.

Throughout the development of the DDS various scenarios were prepared and presented to Councillors from all political groups for discussion to help demonstrate what possible options might be available; however no firm consensus was reached by Councillors on a preferred option from this suite of scenarios. The professional advice from experienced and qualified planning officers in this situation was therefore to consult on an option which in their opinion is best likely to provide the most sustainable pattern of development across Bromsgrove District and this was the option presented in the Draft Development Strategy.

The Extraordinary Council meeting took place on 19 June 2025. It was not always the best of tempered of meetings and some Councillors tried to put forward an amendment to the recommendation. They tried to make it about specific sites, but this was a vote to continue a process. A process of

The recommendation was passed by a majority.

The consultation will run until 22 September 2025.

Shape Worcestershire Local Government Reorganisation (LGR)

The survey undertaken in June has now closed.

A staggering 4,600 comments were received as part of the survey. Feedback was also received from several focus groups held across the county.

Initial analysis of the survey results reveals:-

- 48% backed creating two unitary councils
- **29**% supported one unitary council for the county
- 19% didn't support any reorganisation of local councils in Worcestershire

Respondents from Bromsgrove District, Malvern Hills District, Redditch Borough and Wychavon were strongly in favour of the two unitary council solution. In Worcester City, 46% favoured creating one unitary council, with 42% supporting the North and South option. In Wyre Forest, opinion was split with 40% backing the one unitary option and 39% supporting creating two unitary councils.

People were asked to consider a range of factors when giving their responses, including how any proposed change would save money, improve local services, simplify local government, support local identity and strengthen community engagement.

The two unitary option was considered better for improving local services, supporting local identity and stronger community engagement. It was felt the one unitary option would be better for saving money/delivering value and making local government simpler.

Staff are now busy analysing the results and further in-depth analysis will be available at a later stage.
